Provider to Provider Consultation Line (PPCL) Pediatric Mental Health TeleECHO Series

The Louisiana Provider to Provider Consultation Line (PPCL) is a no cost provider-to-provider telephone consultation and education program to help pediatric health care providers address the behavioral and mental health needs of their patients.

Using technology-supported mentoring and case reviews, PPCL's TeleECHO series focuses on supporting the treatment of mental and behavioral health concerns in children and adolescents in primary care settings. During TeleECHO sessions, providers will present de-identified patient cases to expert teams who guide the learners through managing patients with complex conditions. Each session will provide mentorship through case based learning, clinical discussion, and learning from each other's experiences.

Participant Requirements

- Attend at least 50% of the TeleECHO sessions
- Submit and present at least 1 patient case during the 7-month cohort
- Complete surveys to assess the efficacy of the program
- Complete a brief post-session survey after each session attended for continuing education credit

- Free CMEs/CEUs for doctors, nurses, and social workers
- Increased capacity for treating behavioral health concerns
- Feedback about specific patient cases
- Support from peers and other experts

How to Register

To participate in the TeleECHO series, providers are encouraged to register with PPCL at <u>Idh.la.gov/ppcl</u>.
