The survey also must be of interest or pertain to family medicine."

Cancellations must be received in writing prior to the closing date; however, if the sponsor chooses not to fulfill a contract, that sponsor will be subject to the full (single-insertion) price for articles already placed plus a 20% cancellation fee for articles not placed. All articles are accepted and published by the publisher upon the representation that the agency and sponsor are authorized to publish the entire contents and subject matter thereof.
